

- C. Adoption of 2020-2021 Budget:** This budget will raise more revenue from property taxes than last year's budget by an amount of \$54,377 which is a 4.20 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$12,548.00.
- Motion:* I move to adopt the City of Comanche Proposed Deficit Budget for the Fiscal Year of October 1, 2020 to September 30, 2021. *(Roll Call Vote attached).*
- D. Ordinance #07-2020 Appropriation of Funds:** Discussion and possible action to accept or reject Ordinance #07-2020, an Appropriation of Funds for the October 2020 to September 2021 fiscal year.
- E. Adoption of 2020 Tax Rate:** This tax rate will raise more taxes for maintenance and operations than last year's tax rate. The tax rate will effectively be raised by 3.50% and will raise taxes for maintenance and operations on a \$100,000 home by approximately -\$4.00.
- Motion:* I move that the property tax rate be increased by the adoption of a tax rate of \$0.628089 which is effectively a 3.50 percent increase in the rate. *Roll Call Vote attached).*
- F. Ordinance #08-2020 Levy of Ad Valorem Taxes:** Discussion and possible action to accept or reject Ordinance #08-2020, a Levy of Ad Valorem Taxes on all real and personal property within the corporate limits of the City of Comanche.
