Failure to do so could result in fines up to \$1,000, suspension of your driver's license and motor vehicle registration, and impoundment of your vehicle for up to 180 days at your cost.

If a time payment plan is requested an additional \$25.00 State Fee (per offense) will be added to the amount of fine. Failure to Display a Valid Motor Vehicle Inspection Sticker, Valid Vehicle Registration or Expired Driver's License will only be assessed a \$20.00 Administration Fee **IF** corrected and proof is presented to the court by APPEARANCE DATE AS STATED ON THE CITATION and **IF THE ITEM HAS NOT BEEN EXPIRED MORE THAN 60 DAYS.**

Failure to Display Driver's License and No Liability Insurance charges will be dismissed if proof of current Driver's License and Liability Insurance Card are presented to the court by APPEARANCE DATE AS STATED ON THE CITATION.
