

ORDINANCE #12-2017

An Ordinance of the City of Comanche, Texas, amending Ordinance #03-2013 establishing Garbage rates, providing publication and an effective date.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMANCHE, TEXAS:

ARTICLE I. RATES:

Ordinance # 03-2013 is hereby amended to provide for the establishment of garbage rates to read as follows:

SECTION I. RATE CHARGES

(1) CURBSIDE RESIDENTIAL COLLECTION EMPTIED ONCE WEEKLY WITHIN CITY LIMITS:

1 st POLYCART	\$17.99
2 nd POLYCART	\$12.10 EXTRA
3 rd POLYCART	\$12.10 EXTRA

(2) COMMERCIAL POLYCART CONTAINERS EMPTIED ONCE WEEKLY:

1 st POLYCART	\$21.23
2 nd POLYCART	\$14.85 EXTRA

(3) COMMERCIAL POLYCART COLLECTION IN EXCESS OF TWO (2) POLYCART CONTAINERS PER WEEK WILL REQUIRE A TWO (2) YARD DUMPSTER.

(10) PRIOR TO DROP OFF, THE RESIDENT MUST COMPLETE THE PERMIT APPLICATION, AND REMIT THE APPROPRIATE FEE PAYMENT TO THE CITY OF COMANCE AT COMANCHE CITY HALL, 101 EAST GRAND. A CITY EMPLOYEE MUST BE PRESENT BEFORE TIRES MAY BE DROPPED OFF AT THE DESIGNATED AREA AT 901 EAST FLEMING.

(11) HOURS OF DROP OFF: MONDAY THRU FRIDAY, 8:00 a.m. to 4:00 p.m. (EXCLUDING HOLIDAYS).

(12) DEPOSITS FOR GARBAGE ONLY WILL BE FIFTY (\$50.00) DOLLARS.

(13) STATE/CITY SALES TAX WILL BE ADDED TO ABOVE RATE.

(14) NO DUMPING OF YARD WASTE, BRUSH, and TREE LIMBS, RESIDENTIAL OR COMMERCIAL TRASH AND HOUSEHOLD RUBBISH IS NOT PERMITTED FOR DISPOSAL AT THE COMANCHE CITY PARK BURN SITE.

SECTION 2. CHARGES PAYABLE BY WHOM: PURPOSE.

THE CHARGES FIXED FOR THE REMOVAL AND DISPOSAL OF ALL GARBAGE, BRUSH, TRASH, REFUSE OR OTHER WASTE MATERIALS SHALL BE LEVIED AGAINST ALL OWNERS, OCCUPANTS, TENANTS, OR LESSEE USING OR OCCUPYING ANY BUILDING, HOUSE, OR STRUCTURE RECEIVING SUCH SERVICE, SINCE THE PROPER AND PROMPT REMOVAL OF ALL GARBAGE, BRUSH, TRASH, REFUSE MATTER AND OTHER WASTE MATERIALS IS ESSENTIAL TO THE PRESERVATION OF THE PUBLIC HEALTH AND SAFETY, IT IS DEEMED NECESSARY THAT THIS CHARGE BE LEVIED AGAINST EVERY PERSON, OWNER OR OCCUPANT, TENANT OR LESSEE, USING OR OCCUPYING ANY PREMISES, AND THUS PROVIDE FOR MORE EVEN AND EQUITABLE DISTRIBUTION OF THE COST OF THIS SERVICE TO THE CITIZENSHIP ENJOYING THE BENEFITS THEREOF, WHERE AN APARTMENT HOUSE OR OTHER BUILDING IS SERVED WATER THROUGH ONE METER, THE PERSON WHOSE NAME THE WATER ACCOUNT STANDS SHALL BE RESPONSIBLE FOR THE PAYMENT OF THE GARBAGE FEES FOR ALL PERSONS IN SUCH APARTMENT OR BUILDING WHO ARE SUBJECT TO THE PROVISIONS OF THIS ORDINANCE.


SECTION 3. PAYMENT WITH WATER BILLS.



FOR THE PURPOSE OF CONVENIENCE, THE BILLING AND COLLECTION OF THE CHARGES LEVIED FOR THE SERVICE OF THIS ORDINANCE SHALL BE DONE BY THE WATER UTILITIES DEPARTMENT OF THE CITY, AND ALL SUCH CHARGES SHALL BE PAYABLE AT THE OFFICE TO THE WATER UTILITIES DEPARTMENT IN THE SAME MANNER AS OTHER UTILITY SERVICES ARE BILLED AND COLLECTED BY THE WATER UTILITIES DEPARTMENT. ARTICLE II PUBLICATIONS:

This ordinance shall take effect ten (10) days after the date of publication of its descriptive caption in the City of Comanche Chief, the local newspaper of a weekly publication, thus meeting all publication requirements.
